MISSION & BACKGROUND

- **Mission:** MCTOG's mission is to provide advanced individual training and collective staff training for the Ground Combat Element (GCE), manage GCE doctrine and training standard development and refinement, and examine emerging concepts and technology to enhance GCE operational readiness and interoperability in support of the Marine Air Ground Task Force (MAGTF).
- **Background:** The OTTP is specifically designed to support the GCE Commander in the achievement of T1 readiness. This will be accomplished by developing and maintaining programs within MCTOG that are representative, relevant and dynamic in order to meet emerging threats and operational requirements.
- **The OTTP is comprised of four core pillars:**
 1. Formal Training Program
 2. Battle Staff Training Program
 3. Doctrine & Training Support
 4. Concept Development and Innovation

OTTP KEY SUPPORT TASKS

- Provide standardized advanced individual training and certification to GCE Operations Officers, Operations Chiefs and Intelligence Officers and Intelligence Chiefs (TMIC) three times per year by executing the eight week Tactical MAGTF Integration Course (TMIC).
- Provide advanced collective training for company through regiment through the BSTP for 4 GCE Regiments and 10 GCE Battalions.
- Serve as proponent for all GCE doctrine and ensure its synchronization with Training and Readiness manuals.
- Provide GCE SME expertise for concept development, innovation and rapid introduction to the GCE.

KEY PERSONNEL REQUIREMENTS

Site Lead

The Site Lead shall possess the education, experience, and security clearance described below:

EDUCATION

- Possesses a Bachelor's Degree (B.A. or B.S.) from an accredited program.

EXPERIENCE

- Possesses a minimum of three years of experience in military training and education.
- Possesses a minimum of eight years of operational experience in maneuver, aviation, fires, logistics, or intelligence operations.
- Possesses a minimum eight years of demonstrated experience with military doctrine, tactics, and command relationships. Direct participation in real world operations is desired.
- Possesses a minimum of two years of demonstrated managerial skill and experience necessary to manage a remote site.
- Possesses excellent written and oral communications skills.

SECURITY CLEARANCE

- Possesses an Active SECRET security clearance.

KEY PERSONNEL REQUIREMENTS

Program Manager (PM) and Deputy Program Manager (DPM)

The PM and DPM shall possess the education, experience, and security clearance described below:

EDUCATION

- Possesses a Bachelor's Degree (B.A. or B.S.) with major in operations research, computer science, engineering, management.

EXPERIENCE

- Possesses a minimum of 10 years operational involvement in deployment and employment of ground combat, aviation, Possesses a minimum of 10 years demonstrated knowledge of military doctrine, tactics, and military command relationships at the operational command level as measured by actual operational force employment experience.
- Possesses experience with direct involvement in real world operations (desirable).
- Possesses a minimum of four years of experience in DoD modeling and simulation and supporting technologies.
- Possesses a minimum of three years of PM experience.
- Demonstrates experience in contractual pricing and accounting.

SECURITY CLEARANCE

- Possesses an Active SECRET security clearance.
